## Bargaining

- **BCAA - RACC** – Tentative agreement reached; ratification vote to be held May 28.
- **BCAA - Service Locations** – Tentative agreement reached; ratification votes to be held May 17, 21 & 23.
- **BCFED** – Bargaining scheduled for June 10, 11, 25 & 27.
- **BC Transit** – Committee held a town hall meeting with membership on May 7; parties to meet to exchange proposals May 13, 16 & 17; anticipate meeting in June to continue discussions on non-monetary proposals.
- **Berlitz** – Parties reviewed employer's audits on April 18; Noel Gulbransen will take on bargaining for the union going forward.
- **Burnaby English Language Centre** – Parties met May 17; next date scheduled for May 28.
- **Canadian Freightways** – Ratification votes underway for tentative agreement (May 6 to 16); vote count to be held May 31.
- **Capilano University** – Bargaining prep dates scheduled for May 23 & 28; protocol discussion tentatively set for July 11 & 12; bargaining dates scheduled with the employer for August 27 to 30.
- **Coast Mountain Bus** – Committee to review draft proposals on June 3 & 5.
- **Coastal Community Credit Union** – Committee met May 15 to finalize proposals; will be looking for dates to schedule exchange with employer.
- **CUPE 3338** – Parties have discussed protocol; attempting to secure bargaining dates.
- **Enterprise Rent-A-Car** – Membership survey results have been received; committee will meet to review the results and work on proposals; dates with employer will be set once final proposals are in place.

## Bargaining cont.

- **FortisBC Inc. (Electric) & FortisBC Inc. (Gas)** – Parties met April 24 & 25 to finalize report out of sub-committee work; working towards document that will contain uncontested provisions from each respective agreement.
- **Gulf & Fraser Fishermen's Credit Union** – Currently finalizing proposals; Dates with employer set for June 21, 27 & 28.
- **Hertz (and merged Dollar Thrifty employees)** – Bargaining preparation is underway; working on selection of bargaining committee.
- **ICBC** – Parties met earlier this month; will return to the table June 25, 26 & 28 where parties agreed to conclude housekeeping items in advance of monetary and non-monetary items; have agreed on further dates through to the fall.
- **Island Savings Credit Union** – Tentative agreement ratified May 17.
- **IWA Forest Industry PP** – Committee began preparations May 9 & 10; membership meeting to be held May 22; dates with employer tentatively booked for May 30 & 31, June 3 & 4.
- **Kelowna Cabs** – Survey sent to membership; due back May 30.
- **Lu'Ma Native Housing** – Tentative agreement ratified May 2.
- **NDP BC** – Notice to bargaining has been sent out; proposals have been drafted and approved; union working with employer to schedule dates.
- **Seaspan International** – Will be setting up preparation meetings with the committee soon.
- **SEIU 2** – Will be setting up preparation meetings with the committee soon.
- **Teamsters 155** – Membership meeting to review proposals held April 25; Proposals being finalized.
- **TransLink** – Committee met April 23 to 29 to draft proposals.
- **Unifor 114** – Committee met May 6 to formulate proposals.
- **Unifor 1928** – Notice of renewal being sent to employer.
- **Vancouver Taxi** – Proposals being finalized; dates are being set to begin renewal process.
- **VantageOne Credit Union** – Membership meeting scheduled for May 28 to discuss bargaining; survey sent to members with return date of May 27.
- **Westminster Savings Credit Union** – Waiting for decision of LRB on right to picket at other locations of WSCU; employer has indicated they are considering closing the Shaughnessy branch; nothing concrete so far.
