### HOW TO VOTE

**IMPORTANT:**

Voting will be conducted electronically through the MoveUP Member Portal at:  
**memberportal.moveuptogether.ca**

You will need to have an account on MoveUP's Member Portal in order to vote. This ensures a safe and secure voting process. If you have not yet already registered, you will need to do so at:

You will require TWO of the following information to authenticate your registration:

- Membership ID number
- Personal email address

If you do not have your membership ID number, please email our staff at **membership@moveuptogether.ca** with the subject "Membership Card Request" and include the following information:

- First and last name
- Name of your employer and work location
- Home and/or cell phone number
- Personal email address
- Mailing address (ensure this is your residential address and not your work address)

Our Membership Department will follow up with you.

**IMPORTANT: When you log in to the Member Portal, double-check to ensure your work location listed is accurate. If you notice your work location is incorrect, please contact our Membership Department at 604-299-0378 or 1-800-665-6838 immediately as executive council positions are assigned by work location(s) and you are only eligible to vote in an executive council election that represents your area.**
