Bargaining

- Alma Mater Society Survey results have been returned and tabulated; committee will meet to review results and formulate proposals.
- BCGEU Parties met with mediator on October 5; several less contentious proposals were signed off however proposals on wages, working from home, and parity in health and welfare benefits kept parties far apart; parties to go back to mediation on October 14.
- **BCFMWU (Admin)** Survey is out to members; tentative bargaining dates set for mid-November.
- **BCFMWU (Reps)** Meeting with the employer October 7; hoping to schedule dates for mid-to-late November.
- **BC Transit** Preliminary bargaining process is in the works leading up to bargaining.
- **Berlitz** Discussion on rollover agreement took place in the spring; further discussions delayed due to summer vacations; draft MOA was sent to employer for review and feedback.
- **Canadian Merchant Service Guild** Review of bargaining preparation status is underway.
- **Capilano University** Committee has been approved and appointed; initial communications have been sent to membership; survey will be sent out shortly.
- **Cascades Casino** Bargaining process to be initiated next month with eye to begin negotiations in the spring.
- **Catalyst Paper** Review of bargaining status underway.
- **Coast Mountain Bus** Preliminary bargaining process is in the works leading up to bargaining.
- **Coastal Community Insurance** Parties scheduled to meet November 30 and December 7 to 9.

Bargaining cont.

- **Coral Cabs (Richmond Taxi)** Parties to discuss how the sector is being impacted by new mandates.
- **Ecojustice** Parties exchanged proposals October 14 & 15.
- **Fortis-CSC** Common employer discussions proceeding at the LRB; the union is required to provide the LRB with a document comparing the two collective agreements by October 13.
- Hastings Entertainment Parties met on October 6; employer has backed away from idea of a one-year rollover so will go ahead with full scale bargaining.
- IAM 140 Employer has applied under s.33(1) of the labour code to cancel this certification as well as IAM 764 due to no active members; case remains open pending the IAM election results at their convention.
- **IBEW 230** Bargaining is underway.
- Kekinow Native Housing Parties have met numerous dates in September and October; bargaining so far has been relatively non-contentious.
- **Kruger Products** Tentative agreement ratified.
- Ladysmith & District Credit Union Parties will meet in early December to discuss monetary proposals.
- Master Trade Union Review of bargaining status underway.
- **NDP BC** In process of confirming appointment of two bargaining committee members.
- Schneider Bargaining is complete however discussions continue on employer funding full cost of an RRSP matching proposal agreed to at the bargaining table.
- Seaspan Bargaining was on hold for the summer; dates are scheduled for November 5 as well as two more November dates.
- **SEIU 2** Review of bargaining preparation status is underway.
- Sheet Metal Industry Training Review of bargaining preparation status is underway.
- **Southern Rail** Tentative agreement ratified.
- Surrey Metro Taxi Union is in process of setting dates to begin bargaining pending approval of proposals.
- **Teamsters 213** Bargaining process to be initiated this month.
- **Teamsters 213 MBP** Bargaining process to be initiated this month.
