Bargaining

- **Alma Mater Society** – Committee meeting in next two weeks to review survey and formulate proposals.
- **BCGEU** – Tentative agreement reached November 16; ratified by membership November 22.
- **BCFMWU (Admin)** – Committee met to review survey results and formulate proposals; parties will be meeting December 1 for protocol and proposal exchange.
- **BCFMWU (Reps)** – Committee met to review survey results and formulate proposals; parties will be meeting December 1 for protocol and proposal exchange; further dates are set for December 13 to 15.
- **BC Regional Council of Carpenters** – Membership meeting held November 21; dates with both parties in discussion.
- **Capilano University** – Committee to review survey results and formulate proposals in near future.
- **CUPE BC & Locals** – Parties in discussions to schedule dates.
- **Ecojustice** – Tentative agreement ratified by members November 26.
- **Fortis-CSC** – Common employer hearing proceeding at LRB; extension given to employer to review document until November 29; hearing scheduled for December 7.
- **Hastings Entertainment** – Due to complete change in management, bargaining on hold until replacements in place; hope to have survey out by end of year.
- **IAM 140** – Will be discussing possible dates later this month.
- **IBEW 230** – Dates set for December 6 to 10.

- **ICBC** – Full-day meetings scheduled with job stewards and executive councillors in December and January to discuss bargaining process.
- **Kekinow** – Tentative agreement ratified by members November 24.
- **Kruger Products** – Membership ratified tentative agreement.
- **Schneider Electric** – Membership meeting held November 19.
- **Seaspan** – Tentative agreement ratified by members November 25.
- **Southern Rail** – Tentative agreement ratified October 27.
- **Surrey Metro Taxi** – Parties met October 19 & 21 to exchange proposals; no further dates set.
- **TWU (USW 1944)** – Tentative agreement ratified November 19.
- **Vancouver Taxi** – Once proposals are approved, we will approach the employer to schedule dates.
- **Victoria Shipyards** – Parties met November 3 & 4; we are working on finding additional dates.
- **WAVAW** – Tentative agreement ratified November 3.
