### INTERIM ORDER

WHEREAS the Labour Relations Board (the "Board") has received an application dated August 26, 2022 (the "Application") from Vancouver Shipyards Co. Ltd. pursuant to Part 5 of the Labour Relations Code (the "Code") alleging that the Poly-Party Unions have engaged in an illegal strike;

AND WHEREAS the undersigned was established as a Panel of the Board pursuant to Section 117 of the Code to deal with this matter;

AND WHEREAS the Board has read the Application and considered the submissions of the parties at a hearing convened by the Board on August 26, 2022;

AND WHEREAS the parties were afforded an opportunity to present evidence and make submissions;

AND WHEREAS the Board is satisfied that it should order the Poly-Party Unions to refrain from those activities specified in paragraph 1 below on an interim basis pending a decision on the Application.

NOW THEREFORE, PURSUANT TO SECTION 133 OF THE LABOUR RELATIONS CODE, THE LABOUR RELATIONS BOARD MAKES THE FOLLOWING ORDER:

- 1. Pending the final resolution of the Application, the Poly-Party Unions and their members are to cease and desist from the impugned activity, i.e., refusing to cross the picket line of the Canadian Merchant Service Guild to attend work at the Vancouver Shipyards.
- 2. This Order is in place until varied or amended by application to the Board, or until the Board issues its final decision on the Application.
