Voting will be conducted electronically through the MoveUP Member Portal at:

If you do not have access to a computer and would prefer a paper ballot you must make your request by email to the Returning Officer at **ReturningOfficer@moveuptogether.ca** by no later than 4:30 p.m. PT on Wednesday, April 5, 2023. Your ballot must be received in the MoveUP office by the voting deadline.
