Bargaining

- **Alma Mater Society** – Tentative agreement reached; ratification vote held March 3.
- **BC Civil Liberties Association** – Bargaining committee has been elected and worked with the union representative over multiple sessions. The proposals have been finalized.
- **BCGEU** – Bargaining survey has been sent to membership.
- **BC Hydro** – Tentative agreement ratified March 1.
- **Berlitz** – Tentative agreement ratified March 8.
- **Bonny's Taxi** – Membership meeting to discuss bargaining being held March 12.
- **Canadian Merchant Service Guild** – Tentative agreement ratified February 28.
- **Capilano University** – Employer tabled a set of proposals that have led the parties to impasse. The employer is revisiting their position, and the parties are in discussion on next steps such as mediation and a representative from PSEC joining the table.
- **Cascades Casino (Langley)** – Preparing to commence bargaining.
- **Catalyst Paper** – Bargaining committee being appointed.
- **Coral Cabs** – Bargaining dates set for February 21 and 24.

Bargaining cont.

- **FortisBC** – Bargaining committee is being assembled and hope to engage soon as the FortisBC-CSC is ratified.
- **FortisBC-CSC** – Waiting for response from employer on getting back to the table.
- **IWA Forest Industry** – In the process of scheduling a membership meeting with our members.
- **Neighbourhood Housing Society** – Bargaining committee has been selected; the bargaining survey will be sent to all members this week.
- **New Democratic Party of BC** – Bargaining committee has been selected; the bargaining survey will be sent to all members this week.
- **Nimbus School of Recording & Media** – Mediator has booked out. A strike for a first agreement is likely.
- **PrairieCoast Equipment** – Members voted in favour of strike action on February 8; a mediator has subsequently been appointed and the parties will begin mediation March 17 and 20.
- **Teamsters Local 213 MBP** – Bargaining committee has been appointed and has met with union rep to review the bargaining surveys and formulate proposals. Membership meeting held March 1 to finalize proposals.
- **Telecommunication Workers Pension Plan** – Tentative agreement reached; ratification vote to be held March 13.
- **Working Ventures** – A membership meeting was held on February 7 to discuss bargaining. A protocol agreement has been signed by the parties, and bargaining is currently scheduled for the last week of April 2023.
