

# Labour Council Delegate Report



February 2024



## Bargaining

- **BC Civil Liberties Association** – The parties have met on several occasions and bargaining is going well. The parties last met on February 2.
- **BC College of Nurses and Midwives** – The parties have met regularly over the past few months.
- **BCGEU** – The bargaining committee met with the employer for bargaining in January 2024. Additional bargaining dates have been set with the employer for later in January and February 2024.
- **Beach Place Ventures (Black Top Cabs)** – The tentative agreement was ratified on December 20. The members are to receive 3% upon ratification, 1.5% annually in this agreement and 1.15% of their gross earnings between 2020 and 2023 as their signing bonus.
- **Cascades Casino Langley** – The parties met in January. One committee member stepped down and has recently been replaced.
- **FortisBC** – The parties met multiple times in January, and we have further dates set for February, March, April and May. Bargaining is not going well - the employer is asking for drastic concessions.
- **Greenpeace Canada** – Bargaining 101 has been sent to membership and the bargaining survey will follow shortly.
- **IAM 250** – The collective agreement was ratified by the membership on December 2.
- **IBEW 230** – Bargaining 101 has been sent to the membership.
- **Island Savings** – Union rep is working on the bargaining committee appointment. A membership meeting pertaining to a defined benefit pension plan was held on January 9.

## Bargaining cont.

- **Kelowna Cabs** – Bargaining dates were scheduled with the employer from January 17 to 19. A tentative agreement was ratified February 1.
- **Konica Minolta** – A membership meeting pertaining to the bargaining survey results was held on January 10.
- **Kruger Products** – A bargaining committee has been formed.
- **Reach Gallery** – Parties met in November and January. Employer has now declared bargaining is at an impasse. A membership meeting with held January 24 to discuss next steps. We are now awaiting a response from the employer.
- **Starlight Casino New West** – The bargaining committee has been formed. A bargaining survey will be going out to the membership shortly.
- **Teamsters 31** – A tentative agreement was ratified January 31.
- **TransLink** – A tentative agreement was ratified on December 15.
- **TST-CF** – The bargaining committee continued negotiations in Calgary from January 15 to 18. A tentative agreement was reached and the memorandum is being reviewed for sign-off
- **UFAWU** – A tentative agreement on January 31.
