

Labour Council Delegate Report



March 2024



Bargaining

- **Alpine Counselling** – The first membership meeting held February 20. The membership survey has now been sent out.
- **BC Civil Liberties Association** – The parties met again in late February/early March. They are making good process on the union's package for a first collective agreement.
- **BC College of Nurses and Midwives** – The collective agreement was ratified on February 7, and will now expire on December 31, 2027.
- **BCGEU** – Members have voted to take strike action; are currently at the LRB in mediation.
- **Cascades Casino Langley** – The bargaining committee met with the employer for bargaining in February. Members will potentially be taking a strike vote; will be going to the LRB for mediation.
- **Catalyst Paper** – The collective agreement has been ratified and will now expire on April 30, 2025.
- **CIATU** – The collective agreement has been ratified and will now expire on December 31, 2026.
- **CMAW Bargaining** – The collective agreement has been ratified and will now expire on December 31, 2026.
- **Greenpeace Canada** – The parties currently have dates scheduled on March 18, 19, and 20, 2024. A membership meeting was held March 8 to discuss bargaining as well as the staff reduction initiative put forth by the employer.
- **Ironworkers Local 97** – The parties currently have dates scheduled on March 18, 19, and 20, 2024.

Bargaining cont.

- **Konica Minolta** – The bargaining committee has been appointed.
- **MacLure's Cabs** – A tentative agreement has been reached. The ratification vote closes on March 15.
- **Marine Workers & Boilermakers** – The bargaining committee has been appointed.
- **The Reach Gallery** – The bargaining committee met with the employer for bargaining in September, October, and November 2023, and January 2024. Parties are at mediation at the LRB; they are close to a deal.
- **Starlight Casinos** – The bargaining survey has now been sent out to the membership.
- **Vancouver Shipyards** – The employer and the Vancouver Shipyards (VSY) poly-party have met for several dates so far, with dates scheduled in February and March. While progress at the table is not moving as quickly as it does at other tables, there are five unions covered by this collective agreement, with each having input into the language. MoveUP is covered under Appendix F of this agreement, however the main agreement also still applies to MoveUP where no similar language exists in Appendix F.
- **VantageOne** – The bargaining committee started the negotiations with the employer on January 16, 2024 and will be looking for additional dates in March and April.
- **Xylem Water Solutions** – The bargaining committee has been appointed.
