Bargaining

- **Alpine Counselling** – The tentative agreement was ratified by the membership on February 5, 2025.
- **BC Regional Council of Carpenters** – The parties are at an impasse and the employer indicated they want to apply for mediation in January 2025.
- **BC Transit** – The bargaining committee has been appointed.
- **Bonny's Taxi** – The parties met on January 13 and again on January 30 but are still very far apart.
- **Capilano University** – The Bargaining 101 bulletin has been sent to members.
- **Cascades Casino (Penticton)** – The bargaining survey was sent to members.
- **Catalyst Paper** – The bargaining committee has been formed and the bargaining survey has been completed.
- **Ecojustice** – The tentative agreement was ratified on December 12, 2024.
- **Enterprise** – We are working hard to rebuild the relationships at both Enterprise and Hertz. The open period for Enterprise is right now and Hertz is in April. Meetings with the stewards have happened and general membership meetings will be happening too. Calls for job stewards and bargaining committee members has started.

- **Greenpeace Canada** – The tentative agreement was ratified by the membership on January 21, 2025.
- **Hastings Entertainment** – The bargaining committee has been set.
- **Hertz YVR** – Union rep is in the process of forming bargaining committee.
- **ICBC** – The Bargaining 101 bulletin and bargaining survey has been sent to members.
- **Island Savings** – The bargaining committee had bargaining booked for the week of January 15, 20, and 22 to resume bargaining with the employer.
- **Lu'Ma Native Housing Society** – Union met with bargaining committee members on January 16 and 17, 2025, to prep bargaining proposals.
- **Richmond Taxi** – The bargaining committee has been appointed.
- **Salal Foundation** – Unfair labour practice has been filed.
- **Seaspan** – Bargaining committee met and reviewed the bargaining survey and the collective agreement on January 23, 2025, and will be setting a membership meeting shortly.
- **Sheet Metal Industry Training Board** – The bargaining committee has been formed.
- **Starlight Casino** – Bargaining took place January 27-29 but the union and employer are now at an impasse.
- **Tree Island** – The bargaining committee has been formed. Teamsters Local 213 has members here and they have already approached our members with no interest shown.
- **Westland Insurance** – Tentative agreement ratified by membership on January 30, 2025.
